Notes:

- The "Necessary Living Expenses" amounts in this table (hereinafter referred to as the "Necessary Living Amount") refer to the amounts stipulated in Article 122 of the Compulsory Enforcement Act and Article 64-2 of the Consumer Debt Clearance Act. These amounts represent the necessary living expenses for the debtor and their cohabiting relatives or those legally dependent on them. The calculation is based on 1.2 times the local minimum living expense announced by the Ministry of Health and Welfare or the respective municipality over the past year.
- Explanation of the data in this table:
 - The formula for the debtor's necessary living amount = (Minimum Living Expense × 1.2) + (Minimum Living Expense × 1.2) × the number of dependents the debtor is legally obligated to support or the proportion of support they are required to provide.
 - For example, if a debtor resides in Taipei City and has zero dependents, the calculation of their necessary living amount would be: (19,013 × 1.2) + (19,013 × 1.2) × 0 = 22,815.6. After rounding, this equals 22,816 NTD.
